

REESE'S FOOTBALL AT CIRCLE K GREAT LAKES SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. THE SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES RESIDING IN MAINE, MARYLAND, MASSACHUSETTS, MICHIGAN, NEW HAMPSHIRE, NEW YORK, OHIO, PENNSYLVANIA, VERMONT, OR WEST VIRGINIA WHO ARE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. VOID WHERE PROHIBITED.

The REESE'S Football at Circle K Great Lakes Sweepstakes ("Sweepstakes") is sponsored by The Hershey Company ("Sponsor"), 19 E. Chocolate Ave., Hershey, PA 17033 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on September 1, 2021 at 12:00:01 PM Eastern Time ("ET") and ends on November 2, 2021 at 11:59:59 PM ET (the "Sweepstakes Period"). The Sweepstakes consists of nine (9) separate entry periods (each, an "Entry Period") as set forth below:

Non-winning entries **will** carry forward to subsequent Entry Periods. The Administrator's computer is the Sweepstakes official clock.

- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the United States residing in Maine, Maryland, Massachusetts, Michigan, New Hampshire, New York, Ohio, Pennsylvania, Vermont, or West Virginia who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, Circle K Stores, Inc., and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

3. HOW TO ENTER THE SWEEPSTAKES: During the Sweepstakes Period, there are two (2) ways to enter:

A. Website: An eligible entrant may visit CircleKReeses.com (“Website”) and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and ZIP Code. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the Sweepstakes.

B. At Participating Circle K Locations: An eligible entrant may enter the Sweepstakes by following the prompts on-screen at a participating Circle K location cash register to provide his/her mobile phone number associated with his/her registered Circle K Easy Rewards account and click to enter the Sweepstakes. **NO PURCHASE IS NECESSARY to enter via this method.** If an entrant is not an existing registered member of the Circle K Easy Rewards program, but submitting his/her mobile phone number, he/she will be automatically enrolled in the Circle K Easy Rewards program. By submitting a mobile phone number, the entrant provides to Circle K their express written consent to receive text messages using automated technology in response to their request related to the Sweepstakes. If an entrant submits his/her mobile phone number to Circle K, he/she is consenting to receive marketing text messages using automated technology from Circle K beyond receiving an entry into this Sweepstakes. Consent to receive text messages is not required or a condition of any purchase. An entrant may, at any time, choose to stop receiving text messages from Circle K by sending an opt-out text message stating “STOP” to 855-276-1947. If an entrant sends an opt-out text message, he/she will be sent a reply text message, which will confirm that he/she has been unsubscribed and will receive no further text messages. For help, text the word “HELP” to 855-276-1947.

Entry Limit: Regardless of method of entry, there is a limit of one (1) entry per person per day. If more than one (1) entry per day is received from the same person, telephone number and/or e-mail address, the entries will be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor’s sole discretion, may not be eligible to win a prize. A “day” is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on September 1, 2021 when a day is defined as starting at 12:00:01 PM ET and ending at 11:59:59 PM ET.

NOTE: An eligible entrant may receive a link to the Website using a web-enabled mobile device and scanning the QR Code printed on marketing materials. Once the QR Code is scanned, the entrant will automatically receive a link to the Website on their mobile device. The entrant may then log on the Website in his/her browser and follow the entry steps set forth in this Section 3 to enter. An entrant is not required to scan a QR Code to participate and may go directly to the Website to enter. Note that an entrant cannot receive an entry into the Sweepstakes solely by scanning the QR Code.

IMPORTANT: MESSAGE AND DATA RATES MAY APPLY IF AN ENTRANT ENTERS THIS SWEEPSTAKES ON HIS/HER MOBILE DEVICE. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Prizes (290 total): The following prizes are awarded as Circle K gift cards (each, a “Prize”) in the indicated Entry Period:

- i. \$10 Circle K gift card (100 total, 50 in each of Entry Periods 1 and 6). Individual ARV: \$10.
- ii. \$25 Circle K gift card (55 total, 25 in Entry Period 2 and 30 in Entry Period 7). Individual ARV: \$25.
- iii. \$50 Circle K gift card (55 total, 25 in Entry Period 3 and 30 in Entry Period 8). Individual ARV: \$50.
- iv. \$75 Circle K gift card (25 total, only in Entry Period 4). Individual ARV: \$75.
- v. \$100 Circle K gift card (55 total, 20 in Entry Period 5, 35 in Entry Period 9). Individual ARV: \$100.

No more than two hundred ninety (290) total Prizes are available in the Sweepstakes.

B. Total ARV: The total ARV of all Prizes available in the Sweepstakes is \$12,500.

C. Odds of Winning: The odds of winning a Prize depend on the number of eligible entries received for the applicable Entry Period.

D. General Conditions: The use of a gift card is subject to the terms and conditions set forth thereon which shall govern the use of the gift card. After the random drawing, Administrator will notify each potential winner via e-mail at the e-mail address provided at the time of registration, or if no e-mail address is on file associated with the potential winner's Circle K Easy Rewards account (if the winning entry was made via Circle K Easy Rewards phone entry as set forth in Section 3B), via phone at the phone number associated with the potential winner's Circle K Easy Rewards account. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a Prize, the respective Prize may be forfeited. If a Prize is forfeited, the Prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries received for that Entry Period, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a Prize, the Prize may not be re-awarded. Upon verification of eligibility, Prizes will be mailed to the winners at the physical addresses (P.O. Boxes are not permitted) provided at the time of entry. In no event will more Prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical, administrative, printing, production, computer or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner.

8. **DISPUTE RESOLUTION:** Except where prohibited, by participating, entrants agree that all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant(s) and Sponsor, shall be governed by and construed exclusively in accordance with the laws of the Commonwealth of Pennsylvania without giving effect to any principles of conflicts of law of any jurisdiction and that: (a) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes shall be resolved individually, without resort to any form of class action; (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with participating, but in no event attorneys' fees; and (c) under no circumstances will any entrant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
9. **PRIVACY:** Entry information provided is subject to the Sponsor's privacy policy, which is available at https://www.thehersheycompany.com/en_us/home/privacy-policy.html.
